

BOOKING OF ECORKM IS SUBJECT TO FOLLOWING TERMS & CONDITIONS

1. A day is reckoned from 06:00 AM to 06:00 AM on the next day or any part of the day.
2. Electric charges for decoration and charges for water supply will be payable in addition to the rental charges based on actual meter reading.
3. Use of Shamiana and decorating is permitted without any loss/damage to the structure inside or outside of Kalyan Mandap and should be removed the same within the Booking hours otherwise hourly basis Booking charges will be recovered from the security deposit.
4. Addition / alternation, nailing, painting by colours etc on the walls of the "Kalyan Mandap" are not allowed under any circumstances.
5. Amplifiers may normally be used within the premises & inside the Kalyan Mandap. It must be used in such a way that it should not be a nuisance to the neighbors in the colony. Such amplifiers should be made use of only between 06:00 AM to 09:00 PM. Applicant has to ensure while using the fire crackers the decibel limit of the crackers should be as specified in the Noise Pollution Act. Use of fire crackers is restricted colony premises during procession. Any deviation will be compelled for forfeiture of full security deposit.
6. The allottee shall have hand over the premises of the Kalyan Mandap in as neat and tidy condition as it was given to him.
7. The allottee should arrange to keep the garbage and cooking wastage in Gunny bag/Polythin bag and thrown it in the dustbin, otherwise extra cleaning charges will be recovered.
8. Smoking /Gambling / Consumption of Alcohol in any manner inside/ in the premises of Kalyan Mandap is strictly prohibited. In case of any deviation, the allottee/guarantor shall be held responsible.
9. Dinning inside the Hall is strictly prohibited.
10. Firing and sound pollution in the Railway colony even in the premises of the Kalyan Mandap is strictly prohibited.
11. The Managing Committee is not responsible for any theft or loss of life and property of the allottee or anybody during and after the period of occupation of the Kalyan mandap.
12. The allottee is only licensee and not a tenant. Hence, the decision of the Managing Committee shall be final and binding on the allottee.
13. The allottee will abide by all the rules and regulation of the Kalyan Mandap including Civil Laws in force. Violation of any of the above rules & regulations may be lead to withheld of security deposit.
14. The President & Members shall have the right to inspect the use premises even when the function are being held to check up the type of use to which the Kalyan Mandap is being put to by the allottee.
15. The President of the Kalyan Mandap will decide the interpretation of any of this rule or any other point not covered in this rules and his decision is Final.
16. In case of non-supply of water due to failure of Pumps and Electrical power supply, the allottee is to make his own arrangements. Kalyan Mandap will not take the responsibility for its supply.
17. Final booking Order to be deposited with the Caretaker to prove the genuineness of the Booking. Occupants will co-operate with the Kalyan Mandap staff for smooth functioning of the same.
18. The marriage procession party after entering the Rail vihar main gate take immediate right turn from the main gate & then left turn to reach the Community Hall. Necessary permission to be obtained by the allottee from the Civil Authorities for procession.
