  - Sparing memo should have the signature of the transferred employee and his thumb impression both of which should be duly attested by the officer signing the release memorandum/order with officer's name and designation appearing below the signature.
6. As per instruction contained in Railway Board's letter No. ERP/Portel-Transfer/2013, dated 30.04.2014, Inter Railway Mutual transfer of Sri Manish Ghosh Tailor, Ch. OS working under SEN/TM/KUR division of this Railway being senior may be released first with a direction to report to cadre section of DRM(P)/CKP/SER and Sri Himansu Sekhar Pradhan, Sr. Clerk working under Sr.DPO/CKP division of South Eastern Railway may be directed to report GM(P)/ECoR/BBS for his further posting.
