

- NB:- 1) The posting Order of the above staff is provisional subject to staff being free from SPE/Vig & DAR clearance if any pending against them. - 2) The tenure of such posting against Ex-Cadre basis is maximum 05 years except the staff at Srl.No-1 & 03. The lien of all the 04 staff to be maintained in their parent units. After completion of tenure period, the staff concerned will be repatriated back to their original parent lien unit/Cadre.
- 3) Since Sri Penta Radhakrishna,Ch.OS/MDTC at Srl-01 and Sri A.Srinibasa Rao Dora Khalasi at Srl 03 above have been working in MDTC/VSKP for more than 05 years, their tenure will be only for 06 months from the date of issue of this posting order or availability of new incumbents whichever is earlier.
