

3. The above employees may exercise option for fixation of pay, if any, from the date of annual increment within one month from the date of issue of this order.
4. The qualifying services of the employees at Sl.No.2 is deferred by 14 days, Sl. No.3 by 3 days, Sl. No.4 by 267 days and Sl. No.5 by 121 days due to absent/LWP.
5. Employee at Sl.No.3 was erroneously granted second upgradation on 01.09.2008 instead of 02.09.2008 and employee at Sl. No. 4 was granted second upgradation on 01.09.2008 instead of 09.11.2008. The dates of 2nd upgradations are revised to 02.09.2008 and 09.11.2008 for employees at Sl. No.3 and Sl. No 4 respectively.
