NOTIFICATION

Sub: Notification for filling up Ex.Cadre post of TLC/DPC in Level-6 on tenure basis in Electrical department of ECoR/HQ/BBS.

Ref: Railway Board's letter No. E (P&A) II-83/RS-10(IV) dated 25.11.1992,
No.E(P&A)II-83-RS-10,dtd.9.1.1998,No.E(P&A)II-2007/RS-14,dtd26.3.2009,
& E(P&A)II-2009/RS-17 dtd. 3.7.2019.

It has been decided to fill up TLC/DPC posts in Electrical department of ECoR/HQ Office/BBS by drafting Loco running staff on tenure basis in terms of Railway Board's letter under reference.

(1) **No of posts:-** 04(Four)

(2) **Eligibility condition:**

(A) The following categories of Loco Pilot & Drafted staff who have completed the cooling off period of equal duration having 75,000 KMs of actual driving experience are eligible to apply.

(i) Loco Pilot (Goods) in Level-6

(ii) Loco Pilot (Passenger) in Level-6

(iii) Loco Pilot (mail/Express) in Level-6

(B) Medical de-categorised Loco Pilot up to A-3(Aye Three) Medical classification who has a minimum of 75,000 KMs of actual driving experience are also eligible to volunteer for drafting as Diesel Power Controller/Traction Loco Controller/ Traction loco Controller.

(3) **Tenure:-** The tenure of posting of TLC/DPC is three years i.e. three years with a cooling off period of equal duration. However, this condition will not apply to the medically de-categorised drivers drafted as DPC/TLC. The tenure of posting of Running staff drafted to perform the duties of DPC/TLC beyond 03 years on year to year to basis upto a maximum period of 05 years (i.e 3+1+1) keeping in view the administrative requirement. (RBE No.162/2004)

(4) **Mode of selection:** The eligible optees will be called for to appear in the screening test as per Estt Srl No. 38/98 & RBE No. 51/2009. Only the suitable candidates will be drafted for a period of 3(Three) years to work as DPC and they shall be governed under all the terms and conditions as per extant rules.


(5) **Maintenance of Lien & Seniority:** The lien and seniority of the candidates selected for the posts of TLC/DPC will be maintained in their respective lien unit/division/cadre from where they have been drafted.

- (6) **Pay, Allowance & other conditions:** In the eventuality of selection to the post of TLC/DPC the selected candidates are eligible for payment of allowance in lieu of kilometrage of 120 KMs per day at the rates applicable to them. They are not eligible to claim TA/DA and special pay. They will continue to progress in the running cadre and will be subjected to all the terms & conditions of service as applicable to running staff including pay & allowance, periodical medical examination, selection/ suitability test etc.
- (7) **Mode of submission of option application:**
Willing & eligible staff fulfilling eligibility conditions may submit their option application in the prescribed format enclosed in Annexure-'A' to their Controlling Officer by 02.9.2022. The Controlling Officer after certifying driving experience and other particulars should forward all the applications in a single bunch to the Personnel Officer of division by 07.09.2022. Personnel Officer of concerned division after verifying service particulars of optees to submit the applications to PCPO Office in a single bunch by 14.09.2022. Running staff fulfilling eligibility conditions working in other unit having lien in division of ECoR may apply through their controlling officer of lien unit. While filling up the application, the applicant should fill up the actual driving experience at the appropriate place in the enclosed format.
- (8) **Other Conditions:** If any provision/Railway Board's guidelines is omitted that is to be treated as valid and operative.
- (9) Administration reserves the right to increase/decrease the number of posts at any stage as per administrative requirement.

This notification may be given wide publicity among running staff of division and staff working in other units having lien in division to avoid complain at the later stage.
