





Preamble

Divisional Railway Hospital, East Coast Railway, Sambalpur (SBP) is a 35 bedded hospital offering Medical services to railway employees and beneficiaries in Sambalpur. At present, Divisional Railway Hospital/SBP is catering to the medical needs of around 6500 employees and their family members and around 120 Retired employee and their dependents. Though Divisional Railway Hospital, SBP has a functioning Laboratory, X-Ray, USG unit for routine pathological & Radiological investigations, the hospital is outsourcing the Radiological investigations like MRI, CT Scan & PET scan etc. from tied up referral Diagnostics Centers/Hospitals.


Divisional Railway Hospital, East Coast Railway, Sambalpur (SBP) is planning to empanel Diagnostic Centres/Hospitals in SAMBALPUR for engaging in providing the Radiological investigations like MRI, CT Scan & PET scan etc. facilities to the Railway beneficiaries catered by it as per Railway Board guidelines on "Standard Operating Procedure in outsourcing work of Clinical investigations including Pathological, Radiological-MRI/CT scan and special investigations vide Rly. Board's L.No.2011/H/6-4/policy, dated: 03.2.2015".

Expression of Interest (EOI) is invited through sealed application from the Diagnostic Centers/Hospitals in SAMBALPUR intending to enter into mutual agreement with Divisional Railway Hospital, Sambalpur for providing the Radiological investigative services.

Minimum Eligibility Criteria
for providing Radiological investigative services

1. The Diagnostic Centers/Hospitals must be NABL/NABH/ISO Certified.
2. The Diagnostic Centre/Hospitals must have been registered with State Government.
3. The Diagnostic Centre/Hospitals should have Radiologist and technicians as per NABL/NABH/ ISO Certification.
4. The Diagnostic Centre/Hospitals should have registered under PNDT Act, if ultrasonography facility is available.
5. The Diagnostic Centre/Hospitals should have AERB approval for imaging facilities.
6. The Diagnostic Centers/Hospitals should have complied with statutory requirements including that of Bio-medical Waste Management & fire safety etc. and should have clearance from Pollution control board.
7. The Diagnostic Centre/Hospitals should have complied with statutory requirements including that of Waste Management & fire safety etc.
8. The Diagnostic Centre/Hospitals should be willing to accept emergency cases at any hour from the hospital.
9. The validity period of all the documents/registrations/certificates, wherever applicable, must cover the MOU period.

Terms & Conditions

for providing Radiological investigative services

1. The rates to be paid by Railway to the diagnostic centers/hospitals shall be as per the CGHS Bhubaneswar rates. In case CGHS Bhubaneswar rate for a particular investigation is not available then CGHS rate of nearest city is applicable. In case CGHS rate for a particular investigation is not available then AIIMS rate or any other government hospital rate shall be applicable, whichever is less. In case no government rate is available then reasonable rate as per mutual agreement between Railway and the centre shall be payable.
2. The Diagnostic Centers/Hospitals should be willing to accept cashless services on bill payment on monthly basis. Bills should be sent monthly in triplicate, and should be accompanied by a copy of each of requisition form. The Diagnostic Centers/Hospitals shall deliver reports in duplicate to the hospital in person.
3. The tenderer or his representative should be available over phone whenever called for.
4. In emergencies, the Diagnostic Centers/Hospitals should be prepared to inform Reports over the telephone/e-mail.
5. The Diagnostic Centers/Hospitals must be standard one and should be equipped with standard equipments, reagents and trained manpower.
6. The team of doctors constituted by CMS/SBP shall visit the Diagnostic Centers/Hospitals at any time either before entering in to a contract, or at any time during the period of contract. The tenderer shall be prepared to explain/demonstrate to the queries of the members.
7. All technical and commercial terms and conditions shall be decided through separate agreements through MOU regarding empanelment.
8. While the EOI responses may contains commercially relevant information, it will not be construed to be a commercial bid. The Diagnostic Centers/Hospitals are advised to carefully review and submit all relevant information along with their EOI bids.
9. Once the EOI bids are received, CMS/SBP and team of doctor's nominated by CMS/SBP as per RB guidelines, will evaluate and finalize the most suitable firms for its empanelment.
10. CMS/SBP reserves the right to reject any or all the Expressions of Interest without assigning any reason thereof.
11. The process of inviting EOI is for ascertaining various options available to CMS/SBP. After evaluation/examination of the offers, CMS/SBP may decide at its sole discretion, the further course of action.
12. CMS/SBP reserves the right to deal with the proposal in any manner without assigning any reasons for the same. The decision of CMS/SBP in this regard shall be final.




