Commercial Circular No. 02(G) /2010

Sub: Hire Charges for Test Wagon.

In addition to the terms and conditions notified vide Board's letter No. TCR/2205/96/1 dated. 02.05.2008 (Rates Circular No. 22 of 2008, Circulated vide this office Commercial Circular No. 56(G)/08 dtd.07.05.2008), on the above subject, sanction of the Central Government is accorded to the following terms and conditions also:

(i) Free time of five hours may be allowed for the purpose of testing after arrival of the test van/wagon at the siding where the weighbridge is located and normal demurrage charges may be levied for detention at the siding on customer's account after five hours. Demurrage Charges should not be levied after its release by the customer irrespective of actual dispatch of test van/wagon. Further, all the rules regarding Demurrage Charges pertaining to waiver/write off, as well as refund shall be applicable.

(ii) Distance for charge may be reckoned for each weighbridge, on the basis of actual distance of movement or from the base station(where the test van/wagon is stationed) upto the station/ siding of the customer where the weighbridge is located and back, whichever is higher.

(iii) Normal shunting charges may be levied for any shunting of the test van/wagon done by railway engine at the siding where weighbridge is located.

2. These instructions will come in force with effect from 21.01.2010.

3. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.

All concerned to note and act accordingly.
