Sub: Transportation of drinking water and fodder to notified drought affected districts of various states: Free of charge.

Ref : Board,s letter No. TCR/1147/2009/3 dated 30.11.2009 (Rates Circular No. 64 of 2009) CCM/ECoR's Commercial Circular No. 180(GC)/09 dated: 03.12.09.

In continuation of Board's letter No. TCR/1147/2009/3 dated 30.11.2009 (Rates Circular No.64 of 2009) CCM/ECoR's Commercial Circular No. 180(GC)/09 dated 03.12.09, sanction of the Central Government is accorded, as a special case, for the transportation of the drinking water and fodder by rail, free of charge, to the notified drought affected districts of Orissa also at "no cost" to the state.

2. These instructions will come into force with immediate effect and remain valid upto 31.01.2010.

3. All other terms and conditions stipulated in the letter under reference will continue to apply unchanged.

4. Special care shall be taken by the Railway's Traffic Accounts Office for maintenance of separate account for such booking. Division will ensure submission of state wise monthly report for the traffic booked and freight forgone to Board's office by 15th of the following month as per the procedure already laid down in Board's letter No.2003/ACII/45/5 dated 07.08.2003.
