Commercial Circular No. 05(G)/10

Sub:- Rebate in freight to (i) M/s BALCO for transportation of Alumina and (ii) M/s Rajshree Cement for transportation of bulk cement, transported in privately owned wagons.

Ref:- Board's RC No. 60 of 2009, dated 29.10.2009 circulated vide this office commercial circular no. 04(G) of 2010.

- 1.0 In terms of Rates Circular No.60 of 2009, instructions were issued for grant of rebate in freight for Bulk Cement and Alumina when loaded and transported in privately owned BCCW and BTAPHP wagons.
- 2.0 The rebate in freight to M/s BALCO has been permitted for loading of Alumina in BTAPHP wagons from Ambadola to Korba. M/s BALCO has requested to permit movement from VIZAG to Korba as their siding at Ambadola is under development.
- 3.0 It has been decided to permit movement of Alumina by M/s BALCO from VIZAG to Korba till the siding at Ambadola is developed.
- 4.0 All other details of Rates Circular No.60 of 2009 will continue to apply for the aforesaid stream of traffic also.
- 5.0 These instructions will come into effect from 20.12.2009 and shall be valid upto 30.09.2010.
- 6.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.
