### **Commercial Circular No. 19(GC) /2010**

Date: 18.02.2010

Sub: Transportation of drinking water and fodder to notified drought affected districts of various states: Free of charge.

Ref: Board's letter No.TCR/1147/2009/3 dated 30.11.2009 and 08.01.2010 (Rates Circular No.64 of 2009 and Rates Circular No.02 of 2010) circulated vide CCM/ECOR's Commercial Circular No. 180(GC)/09 & 03(GC)/2010 respectively.

In continuation of Board's letter Nos.TCR/1147/2009/3 dated 30.11.2009 and 08.01.2010 [(Rates Circular No.64 of 2009 and Rates Circular No.02 of 2010) circulated vide CCM/ECOR's Commercial Circular Nos. 180(GC)/09 & 03(GC)/2010 respectively], sanction of the Central Government is accorded, as a special case, for extension of the existing instructions for a period of six months that is upto 31.07.2010 for the transportation of drinking water and fodder by rail, free of charge, to the notified drought affected districts of the notified States at "no cost" to the states.

2. All other terms and conditions stipulated in the letters under reference will continue to apply unchanged.
