Sub: Introduction of Yuva Trains.

Letter, dated: 13.01.2010, received from Railway Board, regarding Introduction of Yuva Trains is reproduced below: -

In accordance with the Budget announcement for 2009-10, a new train service called "Yuva Train" is being introduced. This train will comprise of AC Chair Car Class only.

2. The 'Yuva Fare' is applicable in this train and unemployed persons between the age group 15-45 years holding Certificate issued under National Rural Employment Guarantee (NREGA) or Registration Card, the validity period of which has not expired, issued by a Government run Employment Exchange will be eligible for availing this fare. Manning of these trains will be done Leg-wise.

3. Carrying of Original Certificate as referred to above is essential while traveling by this train for the purpose of verification. If any passenger booked under Yuva Category fails to produce the Original Certificate during the journey, difference of Yuva Fare and total Non-Yuva fare applicable in Yuva Train inclusive of surcharge in full will be recovered from such passengers.

4. The benefit of Yuva Concessional Fare will not be given after preparation of chart. The unutilized accommodation in these trains will be available on payment of full fare after the preparation of chart. Ticket Checking Staff may be instructed that passengers approaching them for accommodation in this train either at originating stations or enroute stations will be charged as per normal rules i.e. non-yuva fair fare even if the passenger is holding Concessional Certificate as stated above.

5. The detailed instructions and fare structure of Yuva Express train have been circulated to Divisions vide this office Commercial Circular Sr. No. 07(C)/10, Dt: 18.01.2010 {Board's Commercial Circular No. 70 of 2009-(Lr. No. TC-II/2910/09/Yuva, dated: 22.12.2009)}. The same may be linked for further action.
