“Reference Board's Commercial Circular No. 26 and 40 of 2009. It has been brought to the notice that concession is denied at some stations to awardees of President's Police Medal for distinguished services and Indian Police Medal for Meritorious Services. It is reiterated that the concession in train fares is admissible to Police personnel of 60 Years who have been awarded the Presidents Police Medal for distinguished service or Indian Police Medal for meritorious service. The element of concession is 50% for men and 60% for women. This concession is admissible in the basic fares of mail/Express trains of all classes and in the all inclusive fares of Rajdhani/Shatabdi/Jan Shatabdi trains. Necessary instructions may be issued to all concerned immediately and implementation ensured. Matter most urgent.”
