Letter received from Railway Board is reproduced below:-

A representation has been received from the two nominated(Anglo-Indian) Members of Lok Sabha stating that since they have no constituency of their own, the income certificate issued by them are not being accepted by Railways for issue of Izzat MSTs.

The matter has been examined. It has been decided that since the two nominated Members of Lok Sabha have no constituencies of their own, the income certificates issued by them for persons of districts in which such MPs normally reside may be accepted for issue of Izzat MSTs. Necessary action may be taken accordingly
