

Sub: Concession orders to students visiting their home towns during vacation can be issued 90 days in advance from the date of commencement of outward journey.

Telex/post copy received from Railway Board is reproduced below:-

“Reference S.No.4 of IRCA Coaching Tariff No.25 Part-I (Vol-II) (Correction Slip No. 2 of 18.12.2003) wherein it has been mentioned that ‘the period of advance reservation being two months, concession orders to students visiting their home towns during vacation can be issued two months in advance from the date of commencement of outward journey.’ Since the period of advance reservation has been changed to 90 days the above rule may revised as “ **The Period of advance reservation being 90 days, concession orders to students visiting their home towns during vacation can be issued 90 days in advance from the date of commencement of outward journey.**” Necessary clarification may be issued to all concerned immediately. Matter most urgent.”


