Sub: '**Comprehensive Parcel Leasing Policy**'- powers to consider appeal against cancellation of registration of leaseholder termination of lease contracts.

1.0 Para (K)-16 of 'Comprehensive Parcel Leasing Policy' issued vide Freight Marketing Circular No. 12 of 2006 under Board's letter No. 2006/TC(FM)/10/1 dated 28.03.2006, is amended as under:-

Appeal against termination of lease contract or cancellation of registration of the leaseholder will lie to Chief Commercial Managers of the zonal railways, who will decide the case at his own discretion on merits of the case.
