CORRIGENDUM

Sub: Policy Guidelines – Freight Incentive Scheme and Transportation Products.
Ref: Rates Circular No.62 of 2009 and corrigendum thereto, circulated vide
CCM/ECOR's Commercial Circular No.177(G)/09 dated 18.11.09 and
corrigendum thereto.

- 1.0 In terms of Rates Circular referred above, traffic loaded from Ports has been kept out of purview of all the Freight Incentive Schemes.
- 2.0 The matter has been reviewed. Sanction of the Central Government is hereby accorded as a special case to grant incentives to the traffic of bagged consignment loaded from Ports also, under Incentive Scheme for Loading Bagged Consignments in Open & Flat wagons. These incentives will be applicable to those commodities only which have been specifically mentioned under Para 4.1 of the Rates Circular referred above.
- 3.0 Necessary amendment in Rates Circular No.62 of 2009, amended from time to time may be done accordingly.
- 4.0 All other details of the Rates Circular No.62 of 2009, as amended from time to time will remain continue to apply unchanged.
- 5.0 These instructions will come into force with effect from **25.01.2012 and will remain valid upto further advice.**
- 6.0 This issues in consultation with Traffic Transportation Directorate and with concurrence of Finance Directorate of Ministry of Railways.
