Sub: Charges for providing Brakevans in Wagon Investment Scheme (WIS) rakes.

Ref: Railway Board's letter No.2007/TC(FM)/4/3 dt.19.04.07, 01.04.08, 20.03.09, 16.03.10, 14.07.10, 31.12.10 & 27.04.2011 {CCM/ECOR's Commercial Circular No.106(G)/07 dt.07.05.07, 42(G)/08 dt.15.04.08, 62(G)/09 dt.07.04.09, 51(G) /10 dt.06.04.10, 112(G)/2010 dt.23.07.10, 8(G)/2011 dt.19.01.11 and 45(G)/11 dtd.10.05.2011 respectively}.

Please refer to Board's letter No.2007/TC(FM)/4/3 dt.27.04.2011{CCM/ECOR's Commercial Circular No.45(G)/11 dt.10.05.2011} in regard to interim orders of Board for levying of 0.5% additional charges on Normal Tariff Rates (undiscounted freight) as payment for attaching Railway's Brakevan to WIS rakes. These orders were communicated to zonal railways vide above letters under reference. These instructions was valid up to 31.12.2011.

Approval of Ministry of Railways (Railway Board) is hereby accorded for further continuance of the above orders upto 31.12.2012 (31st December 2012) or the date when the WIS Customer procures the Brakevan and it is actually inducted, whichever is earlier.

Matter may be taken up with WIS customers who have not procured Brakevans so far to expedite procurement of Brakevans within the stipulated target date of 31.12.2012
