Sub: Wagon Investment Scheme (WIS).

Ref: Board's letter No.2004/TC(FM)/4/4 pt. dt.26.09.2006.

Please refer to Board's letter under reference wherein guidelines were issued for placement of indents for WIS rakes so that railways can keep a track of guaranteed number of rakes for loading, handling of shortfall in loading, restrictions and operational constraints and processing additional applications etc.

In this connection the provisions contained in para (ii) have been revised and in partial modification it has been decided that the para (ii) of the letter under reference may be amended as follows:

“Railways may direct WIS customers to place indents at equal spacing on the basis of the monthly quota. In case, WIS customer has failed to register indents in time then, he cannot demand carry forward of the guaranteed supply.

Irrespective of the date of registration, with valid pending indents (allotment, wherever applicable) if Railways have failed to supply the guaranteed number of rakes eligible for freight rebate at the end of the month, the pending indents (allotment) eligible for freight rebate will be carried forward till these arrears are liquidated.”

This issues with approval of Board(MT).
