**Sub: Permissible Carrying Capacity (PCC) of 8 Wheeler BG Wagons.**

Ministry of Railways have decided that for the purpose of charging, PCC of different wagons for loading of Coke may be treated at par with Coal.

- 2.0 Necessary modification in the Rates Circular No. 28 of 2011[Circulated vide this office's Commercial Circular No. 80(G)/2011 dtd. 29.07.2011] may be made accordingly.
- 3.0 All other details of Rates Circular No. 28 of 2011[Circulated vide this office's Commercial Circular No. 80(G)/2011 dtd. 29.07.2011], as amended from time to time, will remain unchanged.
- 4.0 These instructions will come into force w.e.f. 20.03.2012.
- 5.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
