**Sub: Dynamic Pricing Policy – Congestion Charge.**

**Ref:** Board's letter No. TCR/1078/2008/11 dtd. 29.03.2011 (Rates Circular No. 13 of 2011) circulated vide CCM/ECOR's Commercial Circular No. 35(G)/2011 dtd.29.03.2011.

1. Vide Para 2 of Rates Circular No. 13 of 2011, sanction of the Central Government was conveyed for levy of Congestion Charge @20% on the applicable Base Freight Rates (as published in the Goods Tariff Part-II) on all traffic booked to Bangladesh and Pakistan. These rates are valid from 1<sup>st</sup> April 2011 to 31<sup>st</sup> March 2012.
2. The matter has been reviewed and it has been decided that the existing rate of Congestion Charge applicable for all traffic to Bangladesh and Pakistan will remain in force for a further period of one year beyond 31<sup>st</sup> March 2012 i.e. upto 31<sup>st</sup> March 2013.
3. All other details of Rates Circular No. 13 of 2011, regarding levy of Congestion Charge, will continue to apply unchanged.
4. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.
