Sub: Exemption of Silver Card holder from payment of Wagon Registration Fee.

In terms of Rates Circular No. 20 of 2011, **Silver Card Holders** who offer traffic from their sidings have been exempted from the requirement of payment of Registration Fee for wagons/rakes indented by them.

The matter has been examined and it has been decided that the paras of Rates Circular No. 20 of 2011 (regarding modification in the relevant rule of Goods Tariff and ACS No. 20 to Indian Railway Code for Traffic (Commercial Deptt) may be treated as withdrawn and para 3.0 (a) of Rates Circular No. 7 of 2006 dt. 20.01.2006 may be modified as under:-

"3.0 (a) Traffic in any commodity offered by Platinum, Gold & Silver card holder from their siding"

Accordingly, Rule 201 (6) (a) contained in Chapter II of Goods Tariff No. 41 Pt.I Vol.I may be modified.

This issues with the concurrence of Finance Directorate of the Ministry of Railways.
