- 1.0 Please refer to Freight Marketing Circular No.2 of 2011 issued vide Board's letter No.2009/TC(FM)/4/2 dated 17.02.2011 (CCM/ECOR'S Commercial Circular No.21(G)/11 dt.21.02.2011.) regarding amendment to Wagon Leasing Scheme.
- 2.0 Para 6.0 (C) may be read as under:-  
"When the rake is on run from originating station to the destination station or on scheduled maintenance, the stabling shall be on Railways account unless expressly asked for by the lessee."
- 3.0 This issues with the approval of Board and concurrence of the Finance Directorate of the Ministry of Railways.
- 4.0 These instructions will come into force with effect from 18.02.2011.
