
Sub: Standard Rake Size for BTPN wagons when loaded with vegetable oil.

In terms of Corrigendum No.15 to Rates Circular No.62 of 2009 [CCM/ECOR's Commercial Circular No. 18(G)/2011 dated 15.02.2011], the standard rake size of BTPN wagons for grant of trainload rate benefit when loaded with vegetable oil was conveyed to Zonal Railways.

Clarification has been sought regarding applicability of these circulars to different types of vegetable oils. The matter has been examined in consultation with Traffic Transportation Dte. It is to clarify that the standard rake composition of BTPN wagons for grant of trainload rate benefit, conveyed vide Corrigendum No.15 to Rates Circular No.62 of 2009, will be applicable to loading of **all commodities mentioned under Group 10 of Main Commodity Head "Hydrogenated and Other Edible Oils"** appearing in IRCA Goods Tariff No.45 Pt.I (Vol.II).

All concerned to note and act accordingly.


