Commercial Circular No.27(G)/2011

## Sub: Classification of Iron Ore.

1. In terms of Rates Circular No. 36 of 2009 and addendum thereto [Circulated vide this office's Commercial Circular No.85(G)/09 dt. 02.06.2009 and addendum thereto], sanction of the Central Government was accorded for fixation of classification of Iron ore and levy of Distance Based Charge on the booking of Iron Ore traffic meant for other than domestic consumption for manufacture of Iron & Steel and Cement.
2. The matter has been reviewed. In continuation of Addendum No.13 to Rates Circular No. 36 of 2009 dtd.24.01.2011 [Circulated vide this office's Commercial Circular No. 10(G)/2011 dt.24.01.2011], sanction of the Central Government is hereby accorded for increasing the existing Distance Based Charge further by ₹100 per tonne on booking of Iron Ore traffic meant for other than domestic consumption for manufacture of Iron & Steel and Cement for all distance slabs. Accordingly, the table given in Para 1.0 of Rates Circular No.36 of 2009 may be replaced with the following table;

Distance in Kms	Distance Based Charge
0-200	125% of Base Freight Rate plus ₹1600/-
201-300	90% of Base Freight Rate plus ₹1600/-
301-400	75% of Base Freight Rate plus ₹1600/-
401-500	45% of Base Freight Rate plus ₹1600/-
501-600	25% of Base Freight Rate plus ₹1600/-
601-700	10% of Base Freight Rate plus ₹1600/-
> 700	₹1600/-

3. All other terms and conditions stipulated in Rates Circular No. 36 of 2009 [Circulated vide this office's Commercial Circular No. 85(G)/09 dated 02.06.2009] will continue to apply unchanged.
4. Monthly appreciation report should be furnished by 7<sup>th</sup> of following month for Board's consideration.
5. These instructions will come into force w.e.f, 03.03.2011 and will remain valid till further advice.
6. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
