Commercial Circular No.30(G)/11

Sub: Wagon Investment Scheme (WIS).

The policy guidelines notified by Railway Board vide Board's letter No.2004/TC(FM)/4/4 pt. dt.03.02.2011 regarding placement of indents for WIS Rakes has been examined and the competent authority (COM) approved the following instructions for incorporation in the notification issued by Dy.CCM(FS) vide letter No.CCM/WIS/375/Pt.II dt.11.02.11 (CCM/ECOR/BBS's Commercial Circular No.16(G) /2011 dt.11.02.2011):-

"WIS customers will place indents at equal spacing on the basis of monthly quota; i.e. in case the guaranteed supply is for 10 rakes a month, one indent should be available by every 3rd day of the month; in case the guaranteed quota is of 8 rakes a month, one indent should be available every 4 day; in case the guaranteed supply is of 6 rakes a month, one indent should be available every 5th day of the month. In case the WIS customer failed to register indents in the above prescribed time frame then the carry forward of the guaranteed monthly supply will not take place.

Irrespective of the date of registration, with valid pending indents (allotment, wherever applicable) if Railways have failed to supply the guaranteed number of rakes eligible for freight rebate at the end of the month, the pending indents (allotment) eligible for freight rebate will be carried forward till these arrears are liquidated."

All concerned to note and act accordingly.
