
Commercial Circular No.32(G)/2011

Sub: 'Inflation concession' on Foodgrains and Kerosene oil.

- 1.0 In terms of Rates Circular No. 11 of 2010 [CCM/ECOR's Commercial No.36(G)/2010 dated 17.03.2010], sanction of the Central Government was accorded to grant 'Inflation Concession' of Rs.100 per wagon on booking of Foodgrains for domestic use and Kerosene oil, subject to fulfillment of certain terms and conditions stipulated therein. These instructions are valid up to 31.03.2011.
- 2.0 The matter has been reviewed. It has now been decided to extend the validity of these instructions for a period of three months i.e. from 01.04.2011 to 30.06.2011.
- 3.0 All terms and conditions as mentioned in Rates Circular No. 11 of 2010 [Circulated vide this office's Commercial Circular No.36(G)/2010 dated 17.03.2010] will continue to apply unchanged.
- 4.0 This issues with the concurrence of the Finance Directorate of Ministry of Railways.
