Sub: Notification of Railway Terminal for chassis stuffing/destuffing & loading/unloading operation.

In terms of Board's Rates Circular No.59 of 2009 (reference -1) & corrigendum there to (reference-2), notification of Railway Terminals as CRT for chassis stuffing/destuffing & loading/unloading were made for operation of container trains by Private Container Operators (PCO) vide this office commercial Circular No.100 (G)/2010 dt.05.07.2010 (reference-3), the currency of which was extended upto 30th April 2011 vide Rates Circular No.29 of 2010 dt.28.10.2010 (reference - 4).

The matter has been further reviewed and it has been decided to extend the currency of extant instructions (as prescribed vide Board's letters under reference) for operation of container trains by Private Container Operator (PCO) in notified Railway owned terminals upto **31.10.2011**.

This issues in consultation with Traffic Transportation Directorate and concurrence of Finance Directorate of Ministry of Railways.
