Sub: Rates for Automobile Traffic carried on NMG, BCACM and BCCNR wagons.
Ref: Rates Circulars No.3/2011, 4/2010 and Rates Circular No.24/2010 [CCM/ECOR's Commercial Circular No.13(G)/2011 dated 04.02.2011, 08(G)/2010 dt.25.01.10 & 115(G)/2010 dt.03.08.10].

In terms of Rates Circulars under reference [CCM/ECOR's Commercial Circular No. 13(G)/2011 dated 04.02.2011, 08(G)/2010 dt.25.01.2010 & 115(G)/2010 dt.03.08.2010], sanction of the Central Government was conveyed to Zonal Railways for revising the freight rates for Automobile Traffic when moved in NMG, BCCNR and BCACM wagons. These instructions are valid upto 03.05.2011.

2.0 The matter has been reviewed and it has been decided that the existing rate may be extended beyond 03.05.2011 for a further period of three months i.e. upto 03.08.2011 subject to fulfillment of existing terms and conditions as stipulated in Rates Circular No.4 of 2010.

3.0 All other details of Rates Circular No.4/2010 will continue to apply unchanged.

4.0 This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
