Sub: Grant of Train load rate benefit to POL rakes partly loaded for railways Fuelling installation and partly for Oil Depot.

It has come to the notice that POL loaded wagons for railway's use are sent in combinations with Oil Depot rakes. As a result Oil companies are not supplied full complement of wagons for loading to form rakes and thus they are not able to comply with the trainload conditions of loading of minimum number of wagons, as stipulated in Rates Circular No.62 of 2009 [CCM/ECoR's Commercial Circular No.177(G)/09 dated 18.11.2009], amended from time to time. Freight charges are therefore being levied at wagon load class rate. The party is thus denied the benefit of trainload class rate which it would have enjoyed had they been allowed full complement of wagons and wagons loaded with POL product meant for railway's own consumption were not made a part of the rake.

In view of the circumstances explained above, it has been decided that as a special case, benefit of trainload rate may be granted to such POL consignments loaded in wagons meant for Oil companies (other than Railways) when clubbed with POL wagons for railway's use. Accordingly, the trainload rate benefit may be granted to the movement of Railway's RCD/HSD traffic alongwith loads of oil companies, loaded to MGS + SFG ex. Panipat and to SBP+RGDA ex.PRDP, subject to fulfillment of all other terms and conditions as stipulated in Rates circular No.62 of 2009 as amended from time to time.

These instructions will come into force w.e.f. 23.05.2011.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.

All concerned to note and act accordingly.
