Sub: - Adjustment in freight rates.

Ref:- Rates Circular No.31 and 33 of 2010 {CCM/ECOR's Commercial Circular No.155(G)/10 dtd.01.11.2010 and 171(G)/10 dtd.21.12.2010}

In terms of Rates Circular 31 of 2010 {CCM/ECOR's Commercial Circular No.155(G)/10 dtd.01.11.2010} Terminal charges on Coal and Food grain was communicated to Zonal Railways. Further, in terms of Rates Circular No.33 of 2010 {CCM/ECOR's Commercial Circular No. 171(G)/10 dtd.21.12.2010} Food grain has been classified at Class-130A.

Clarification has been sought whether these classification and levy of terminal charges is applicable for all commodities of main commodity head "Food grain, flours and pulses" and "Coal and Coke" or on Food grain and Coal only.

The matter has been examined. The clarification is as under:

- I. All commodities of the main commodity head "Food grain, flours and pulses" are classified at Class-130A.
- II. The terminal charge of Rs.20/- per tonne per terminal is to be levied on all commodities of the main commodity head "Food grain, flours and pulses" and "Coal and Coke"

This issues with the concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.
