Considering the issue indicated in the S.E.Railway's letter under reference, it has been decided to modify the instructions of Para 3(c) of this office letter No.2007/TT-III(S)/32/16 dated 29.10.2007 on the subject mentioned above to meet the requirement of Rake Allotment System.

Existing Instructions	Modified Instructions
Priority 'C' customers who offer at least 20% of their production of outward steel/pig iron/sponge iron traffic in a month should be given at least 75% of their iron ore requirements in the subsequent month.	Priority 'C' customers who offer at least 20% of their production of outward steel/pig iron/sponge iron traffic in a month should be given at least 75% of their iron ore requirements in the next to subsequent month.
