Sub: Commodities permitted in Dhamra Port Company Limited siding-Reg.

Ref: CCM/ECoR's Commercial Circular No. 44(G)/2011 Dt. 06.05.2011

1. Vide CCM/ ECoR's Commercial Circular No. 44(G) / 2011 Dt. 06.05.2011 the M/s. Dhamra Port Company Limited siding (Alpha code: **DPCB**, Numerical Code: **12121062**) was notified as a full rake handling point for the following commodities in Train load and Wagon load:
  - a) Outward traffic: - Coking coal, Fertilisers, Containers & POL.
  - b) Inward traffic: - Coal, Iron Ore, Agricultural products, Containers & Steel products.
2. It has been decided to modify the above notified commodities as follows:
  - a) Outward traffic: - Non-programmed Coal under priority-"D", Coking coal, Lime Stone.
  - b) Inward traffic: - Coal, Iron Ore, Agricultural products & Steel products.
3. Non-programmed Coal under priority-"D" will be booked in accordance with the guidelines issued vide CCM/ECoR's Commercial Circular No. 103(G)/08, 144(G)/08, 155(G)/08, 01(G)/09, 66(G)/09, 99(G)/09 and as per the guidelines issued by Executive Director (Rail Movement) /KOL from time to time on the subject.
