Sub: List of combination of two point destination terminals for covered wagons.

Ref: Board's letter No.TCR/1078/2009/13 dated 10.11.2009 (Rates Circular No.62 of 2009) and corrigendum thereto [Circulated vide CCM/ECOR's Commercial Circular No.177(G)/09 dated 18.11.09 and corrigendum thereto].

- 1.0 In terms of Annexure – IV attached to Rates Circular No.62 of 2009 [CCM/ECOR's Commercial Circular No.177(G)/09 dated 18.11.09] amended from time to time, a list of combination of two point destination terminals for covered wagons was notified.
