Sub: Running of freight trains on CC+8 routes.

Ref: Rates Circular No.28 of 2008 {CCM/ECOR's Commercial Circular No.73(G)/08} and addendum thereto, Rates Circular No.41 of 2009 {CCM/ECOR's Commercial Circular No.98(G)/09}, Rates Circular No.21 of 2010 {CCM/ECOR's Commercial Circular No.95(G)/2010}, Rates Circular No.23 of 2010 {CCM/ECOR's Commercial Circular No.109(G)/2010} and Corrigendum thereto.

1. In continuation of Board's letter No. TCR/1394/2004/2 dtd.01.06.2011 (Corrigendum No.3 to Rates Circular No.23 of 2010) {CCM/ECOR's Commercial Circular No.60(G)/11 dtd.02.06.11}, sanction of the Central Government is hereby accorded to include following routes in the list of already identified CC+8 routes:

2.	SCR	Venkatachalam-Krishnapatanam
3.	NCR	Agra Jn-Agra Fort-Yamuna Bridge-Tundla including Etmadpur-Mitawali bypass line

2. All other details of the Rates Circulars under reference will continue to apply unchanged.
3. These instructions will come into effect from 25.06.2011 and will remain valid till further advice.
4. This issues with the approval of Civil Engineering, Mechanical Engineering, Traffic Transportation Directorates and with the concurrence of Finance Directorate of Ministry of Railways.
