Sub:- Re-fixation of siding charge for the private siding of Talcher Thermal Power Station at Talcher.
Ref:- This office's circular No. 151(G)/07 dt.11.07.07 & 60(G)/10 dt.19.04.2010.

It is notified for information and guidance of all concerned that consequent upon the electrification of the private siding of Talcher Thermal Power Station at Talcher over Khurda Road Division, East Coast Railway, the rate of siding charge notified vide this office's circular cited under reference for the subject siding has been further re-fixed w.e.f 28.02.2008 as follows:

Date of effect	Rates of siding charges per trip for placement/drawn out. (in Rs.)
28.02.2008 to 30.06.2008	76012
01.07.2008 to 30.06.2009	76012
01.07.2009 to 30.06.2010	76012
01.07.2010 till further order	76897

Note:

1. The rates of siding charges are to be levied per trip basis irrespective of number of engines attached to the rake.
2. Siding charges to be collected locally by the serving station.
3. No supplementary charge is leviable on siding charges.
4. The above rates of siding charges are to be levied in addition to the freight to / from serving station of the siding.
5. Other conditions notified earlier will remain unaltered.
6. Staff concerned to note and act accordingly.
