Sub: Rates for Automobile Traffic carried on NMG, BCACM and BCCNR wagons.

Ref: Rates Circulars No.3/2011,4/2010,24/2010 and 16/2011 [CCM/ECOR's Commercial Circular Nos.13(G)/2011, 08(G)/2010, 115(G)/2010 and 42(G)/2011 respectively].

- 1.0 In terms of Rates Circulars under reference, sanction of the Central Government was conveyed to Zonal Railways for revising the freight rates for Automobile Traffic when moved in NMG, BCCNR and BCACM wagons. These instructions are valid up to 03.08.2011
- 2.0 The matter has been reviewed and it has been decided that the existing rate may be extended beyond 03.08.2011 for a further period of two months i.e up to 02.10.2011 subject to fulfillment of existing terms and conditions as stipulated in Rates Circular No. 4 of 2010 [CCM/ECOR's Commercial Circular No.08(G)/2010 dated 25.01.2010].
- 3.0 All other details of Rates Circular No. 4 of 2010 will continue to apply unchanged.
- 4.0 This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
