Sub: Two point combinations for steel traffic.

Ref: Board's letter No.TCR/1078/2009/13 dated 10.11.2009 (Rates Circular No.62 of 2009 and corrigendum thereto), circulated vide CCM/ECOR's Commercial Circular No.177(G)/09 dated 18.11.09 and corrigendum thereto].

1.0 In terms of Annexure – VI to Board's letter No. TCR/1078/2009/13 dated 10.11.2009 (Rates Circular No.62 of 2009) [CCM/ECOR's Commercial Circular No.177(G)/09 dated 18.11.09], a list of Two point combinations for other than covered stock (for steel traffic only) was notified.

2.0 It has been decided that the following two point combinations of Annexure-VI under South Central Railway may be deleted:
