The abstract of Railway Board's letter No.2011/TC(CR)/204/13 dated 03.08.2011 is reproduced below for information and necessary action.

"Sub: Classification of Commodity "Nut Coke".
Ref: CCM/FM/RG-1/Commodity/Gen/1/Pt.I/1956 dated 24.06.2011.

With reference to the above communication, it is informed that, as per the guiding principles (2) of IRCA Goods Tariff No.45 Pt.1, (Vol.II) w.e.f. 01.04.2007, "The classification of different commodities under the Main Commodity Head given in the Goods Tariff, if not explicitly mentioned otherwise, will be same for their different physical forms/shapes and different conditions (whether raw or manufactured etc)".

As such, the commodity "Nut Coke" shall be charged at the Main Commodity Head "Coal & Coke" under item 8, as Coke Hard. As a result thereof, all rules and regulations including restrictions in movement shall be applicable in its transportation.

This issues with the concurrence of Finance Directorate of the Ministry of Railways.

All concerned to note and act accordingly.
