Sub:Policy Guidelines – Freight Incentive Scheme and Transportation Products.
Ref:Board's letter No.TCR/1078/2009/13 dated 10.11.2009 (Rates Circular No.62 of 2009 and corrigendum thereto, circulated vide CCM/ECOR's Commercial Circular No.177(G)/09 dated 18.11.09 and corrigendum thereto.

1. In terms of Para 4.1 of Rates Circular No.62 of 2009 amended from time to time, a certain percentage of freight discounts is granted on NTR for loading bagged consignments in Open and Flat wagons subject to fulfillment of terms and conditions stipulated therein.
2. The matter has been reviewed. Sanction of the Central Government is hereby accorded to partially modify the Para 4.1 of Rates Circular No.62 of 2009 as per the following;

"In cases, when more than one bagged consignments are clubbed/loaded in open and flat wagons, the applicable freight discount to that consignment may also be granted on pro-rata basis subject to fulfillment of all other terms and conditions".

Illustration: If cement is clubbed and booked along with Fly Ash (both as bagged consignments in open and /or flat wagons, the discount would be @20% for Cement and @30% for Fly Ash.

3. All other details of Rates Circular No.62 of 2009, as amended from time to time, will remain unchanged.
4. These instructions will come into force w.e.f. **25.05.2012**.
5. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.


