Corrigendum to CCM/ECOR's Commercial Circular No.131(G)/11 dt.25.11.2011.

Sub: Change of loading point of M/s VAL's BTCS wagons from CFVS to PGFV.

Railway Board vide Corrigendum under reference (iii) have changed the loading point from Coromandal Fertiliser Ltd, Railway Siding, Vishakhapatnam Port Trust, Vishakhapatnam (CFVS) to M/s Godavari Fertilisers and Chemicals Ltd, VPT (PGFV) for the purpose of grant of rebate in freight for Caustic soda when loaded and transported in privately owned 62 BTCS wagons (50 wagons already procured and 12 wagons ordered for procurement) of M/s VAL. This change of loading point will come into force w.e.f, 01.07.2012
