Sub: Levy of Terminal Charges on Goods Traffic.

Ref Board's letter No.TCR/1078/2007/6 dated 29.10.2010 and dtd.27.10.2011 and 30.03.2012 (Rates Circular No. 31 of 2010, 39 of 2011 and 11 of 2012 [Circulated vide CCM/ECOR's Commercial Circular No.155(G)/2010 dtd. 01.11.2010,122(G)/2011 dated 27.10.2011 and 34(G)/12 of 30.03.2012 respectively].

1. In terms of Rates Circular No 11 of 2012, the following rates for levy of Terminal Charges were notified and which are valid till 30.06.2012:

S.No.	Commodities	Rate per tonne per terminal
(i)	Iron ore traffic	Rs.45/-
(ii)	Coal & Food grain	Rs.20/-
(iii)	All other traffic	Rs 40/-
(iv)	Container traffic	Nil

2. The matter has been examined and it has been decided by the Board that the existing rates of Terminal Charges as mentioned in above Para will continue to apply unchanged.
3. These instructions will come into force w.e.f 01.07.2012 and will remain valid till 30.09.2012
4. All other details of Rates Circulars under reference will remain unchanged
5. This issues with the concurrence of Finance Directorate of Ministry of Railways.
