Sub: Permission to container train Operators to access private sidings for handling and transportation of different commodities in container trains.

Railway Board's letter under reference (ii) is reproduced below for information & guidance.

To attract the piecemeal traffic not carried by Railways from industrial Units connected with private rail sidings, guidelines was issued vide Railway Board letter under reference (i) for considering access to trains operated by Container Train Operators to such private sidings for handling and transportation of commodities in container trains.


Northern Railway has requested for clarification whether the circulars holds good for dealing with inward traffic also.

The issue was examined and it has been decided that "Zonal Railway may permit Container Train Operators to handle their train in private siding for inward traffic also subject to fulfillment of the provisions indicated in the Railway Board letter under reference (i)".

This is issued with the approval of Traffic Commercial Directorate.


