Ref:- CCM/ECOR's Commercial Circular No. 143(G)/2010 Dt. 23.09.2010.


Consequent upon the change in the lay out plan of the take off arrangement and commissioning of "Y" connection for the private siding of M/s. Sterlite Energy Ltd. served by Brundamal Station (Alpha Code: SEBD), the chargeable distance for the subject siding, as notified vide CCM/ECOR's Commercial Circular under reference, has been changed.

Henceforth, the distance for charging to be reckoned, for the Private siding of M/s. Sterlite Energy Limited served by Brundamal Station (Alpha Code: SEBD), as Brundamal (BXQ) + 11.18 Km (Eleven decimal one eight Km) [Authority: DEN (Central) / SBP's letter No. DRG/VAL/BXQ/SBP/Pt.-II/02 Dt. 06.08.2012]

In case, any additional shunting operation is performed by Railway Locomotive inside the siding, necessary shunting charges will be levied separately as per extant rules. All other terms and conditions as stipulated in the CCM/ECOR's Circular under reference will remain unchanged.

This instruction will come into force w.e.f. 08.01.2012.


