Sub: Issue of RR in the case of M/s DPCL siding in ECoR

Ref: Board's letter No. 2009/TCFM/18/32 dt.19.12.2011, dt.19.03.2012 & dt.19.06.2012{CCM/ECoR' Commercial Circular No.138(G)/2011 dt.19.12.2011,27(G)/2012 dt.19.03.2012 & 60(G)/2012 dt.19.06.2012 respectively}.

Please refer to Board's letter No.2009/TCFM/18/32 dt.20.09.2011 vide which it has been decided that in the case of traffic originating/terminating from/to the M/s DPCL siding in ECoR, RRs will be issued in the name of consignor/consignee instead of the port authority. This instruction was extended upto 19.09.2012 vide Board's letter of even number dt.19.06.2012.

The matter has been examined and it has been decided to extend the validity of the afore-mentioned instruction regarding issue of RR for further period of six months i.e. upto 19.03.2013 or till implementation of the policy on Private Ports, whichever is earlier.

This issues in consultation with Freight Marketing Branch of Commercial Directorate and with the concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.
