
1. In terms of Rates Circular No. 16 of 2012, the following rates for levy of Terminal Charges were notified. These instructions are valid till 30.09.2012.

S.No.	Commodities	Rate per tonne per terminal
(i)	Iron Ore traffic	Rs.45/-
(ii)	Coal & Food grain	Rs.20/-
(iii)	All other traffic	Rs.40/-
(iv)	Container traffic	Nil

2. The matter has been examined and it has been decided by the Board that the existing rates of Terminal Charges as mentioned in above Para will continue to apply unchanged beyond 30.09.2012 and will remain in force till further advice.
3. All other details of Rates Circulars under reference will remain unchanged.
4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
