CORRIGENDUM

Sub: List of combination of two point destination terminals for covered wagons.

Ref: Board's letter No.TCR/1078/2009/13 dated 10.11.2009 (Rates Circular No.62 of 2009 and corrigendum thereto), circulated vide CCM/ECOR's Commercial Circular No.177(G)/09 dated 18.11.09 and corrigendum thereto].

- 1.0 In terms of Annexure – IV to Rates Circular No.62 of 2009 [CCM/ECOR's Commercial Circular No.177(G)/09 dated 18.11.09] amended from time to time, a list of combination of two point destination terminals for covered wagons was notified.
- 2.0 The matter has been reviewed. It has now been decided that the following two point combinations under West Central Railway of Annexure-IV may be revised as under:

S.No.	Existing Permitted Combination of stations for Two Point Rake	Revised Permitted Combination of stations for Two Point Rake
15	Itarsi - Bhopal	Itarsi - Nishatpura
16	Banapura - Bhopal	Banapura - Nishatpura
20	Bhopal - Ganjbasoda	Nishatpura - Ganjbasoda

- 3.0 All other details of the Rates Circular under reference will continue to apply unchanged.
- 4.0 These instructions will come into force w.e.f. **01.10.2011**.
- 5.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.
