Sub: Levy of Terminal Charges on Goods Traffic.

Ref: Railway Board's Rates Circular No. 31 of 2010 dated.29.10.2010[Circulated vide CCM/ECOR's Commercial Circular No.155(G)/2010 dtd. 01.11.2010].

In terms of Rates Circular No.31 of 2010, rates for levy of Terminal Charges as per the table give below was notified and these rates are valid till 31.10.2011:-

S.No.	Commodities	Rate per tonne per terminal
(i)	Iron ore traffic	Rs.45/-
(ii)	Coal & Food grain	Rs.20/-
(iii)	All other traffic	Rs.40/-
(iv)	Container traffic	Nil

- 2.0 The matter has been examined and it has been decided by the Board that the existing rates of Terminal Charges as mentioned in above Para will continue to apply unchanged.
- 3.0 These instructions will come into effect from **01.11.2011** and will remain valid till 31.03.2012.
- 4.0 All other details of Rates Circular under reference will remain unchanged
- 5.0 This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
