CORRIGENDUM

Sub:Policy Guidelines – Freight Incentive Scheme and Transportation Products.
Ref:Rates Circular No.62 of 2009 and corrigendum thereto, circulated vide CCM/ECOR's
Commercial Circular No.177(G)/09 dated 18.11.09 and corrigendum thereto.

1. In continuation of Corrigendum No.25 to Rates Circular No.62 of 2009 [CCM/ECOR's Commercial Circular No.133(G)/2011 dated 01.12.2011], it has been decided to modify the provision regarding standard rake size for BRN/BRNA/BRNAHS/BFNS wagon and mixed rake of BOST and BRN/BRNA/BRNAHS/BFNS wagon. Accordingly, the provision related to these wagons mentioned in Annexure-III attached to R.C.No.62 of 2009, amended from time to time may be revised as per following:-

Note :- ***** BRN/BRNA/BRNAHS/BFNS will be treated as one type of wagons.

- 2.0 Indents for BOST and BRN/BRNA/BRNAHS/BFNS wagons will be treated as interchangeable for the purpose of supply of rakes. However, trainload conditions will be applicable as per type of stock supplied. At present, standard rake size and minimum number of wagons to be loaded for BOST wagon for availing trainload benefit is 45 and 43 wagons respectively.
- 3.0 All other details of the Rates Circular No.62 of 2009, as amended from time to time will remain unchanged.
- 4.0 Necessary amendment in Rates Circular No.62 of 2009 amended from time to time may be made accordingly.
- 5.0 These instructions will come into force with effect from **20.12.2011**.
- 6.0 This issues in consultation with Traffic Transportation Directorate, Mechanical Directorate and with concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.
