The matter has been examined and it has been decided **to extend the validity of the instructions** prescribed vide Board's letters No.2007/TC-I/302/1 Pt.H dt.14.02.2011(Rates Circular No.5 of 2011) and dt.30.08.2011 (Corrigendum 1 to Rates Circular No.5 of 2011) **beyond 31.12.2011 upto 31.03.2012, unless otherwise revised earlier.** Accordingly, the provisions of Para 3.0 of the Rates Circular No.5 of 2011 may be revised as under:

"3.0 These instructions will be effective from 01.03.2011 and will remain valid till 31.03.2012, unless otherwise revised earlier."
