Sub: Notification of Bobbili (VBL) station as CRT for chasis stuffing/destuffing & loading/unloading operation.

2) CCM/ECOR's Commercial Circular No.111(G)/2011 dtd.27.09.2011

Vide CCM/ECOR's Commercial Circular under reference (1) notification of Railway Terminals as CRT for chasis stuffing/destuffing & loading/unloading were made for operation of container trains by Private Container Operators (PCO) and the validity of which has been extended upto 30.04.2012 vide various commercial circulars issued from time to time.

At para 3.0 of CCM/ECOR's Commercial Circular under reference (1) the list of stations permitted for loading/unloading as well as chasis stuffing/destuffing operation of containers has been notified. Now, with the approval of competent authority Bobbili station (VBL) of Waltair division is hereby added to the list of existing stations in Para 3.0 of the said circular and hence Bobbili (VBL) is now open for loading/unloading operation of containers along with chasis stuffing/destuffing operation.

All other terms and conditions as well as rates notified by this office through Commercial Circulars related to containers will remain unchanged
